General Court-Martial handles the most severe offenses. Penalties may include lengthy confinement, reduction in rank, forfeiture of benefits, and a dishonorable discharge. General Court-Martial convictions appear on federal criminal records.

Special Court-Martial is often compared to a misdemeanor court. Yet consequences still include confinement for up to one year and a bad conduct discharge that follows service members into civilian life.

Summary Court-Martial applies only to enlisted members and handles minor misconduct. Consequences remain serious enough that every accused service member should request counsel before consenting.

The system may seem structured around punishment, yet you have powerful defense rights. These include the right to silence, the right to review evidence, the right to challenge the command's involvement, and the right to choose your own attorney.
